1. Invoices for payments made to Lamberts Florist and one for John Banks are not filed. For future years please ensure invoices are handed to the Clerk prior to payment.
2. I have noted that figures relating to the standing order amounts for the Clerk originate from the Payroll Accountant.
3. I have noted that there is a ringfenced amount for the Cemetery Extension and Laptop provision, which leads to the high amount of cash and short term investments.

All other records are up to date and in order.



 - commenced judicial review proceedings under section 31(1) of the Act
 - made an application under section 28(1) of the Act for a declaration that an item of account is unlawful, and the application has not been withdrawn nor has the court refused to make the declaration
- The court has not declared an item of account unlawful after a person made an appeal under section 28(3) of the Act.

If you are able to confirm that the above statements apply and that the authority neither received gross income, nor incurred gross expenditure, exceeding £25,000, then the Certificate of Exemption can be signed and a copy submitted to the external auditor **either** by email **or** by post (not both).

The Annual Internal Audit Report, Annual Governance Statement, Annual Accounting Statements, an analysis of variances and the bank reconciliation plus the information required by Regulation 15 (2), Accounts and Audit Regulations 2015 including the period for the exercise of public rights still need to be fully completed and, along with a copy of this certificate, published on a public website* before 1 July 2019. **By signing this certificate you are also confirming that you are aware of this requirement.**




